

आपल्या राष्ट्रपित्याचे वरील वचन माहितीच्या अधिकाराला तंतोतंत लागू पडते. माहितीचा अधिकार म्हणजेच सत्तेच्या दुरुपयोगाला विरोध करण्याचे जनतेला मिळालेले सामर्थ्य. भारताला स्वातंत्र्य मिळाल्यापासून आजपर्यंत अनेक कायदे तयार करण्यात आले. तथापि, शासन व जनता यांची जवळीक साधणारा हा कायदा तसा थोडा वेगळा मानावा लागेल. या कायद्यामुळे आपला सामाजिक दृष्टिकोन बदलणार आहे. इतर सर्व कायदे हे जनतेने पाळावयाचे आणि शासन यंत्रणेने त्यांच्यावर नियंत्रण ठेवायचे, अशाच पठडीतले होते. हा कायदा मात्र प्रशासन पाळणार आहे आणि त्यावर नागरिक नजर ठेवणार आहेत. त्याचमुळे तो एकमेवाद्वितीय ठरतो.

न्यायाधीशांच्या नेमणुका करताना १९८२ मध्येच सर्वोच्च न्यायालयाने एका महत्वपूर्ण निकालाद्वारे 'शासनप्रणाली-बाबत माहिती देणे हा नियम आणि लपवणे हा अपवाद,' असे स्पष्ट केले होते. श्रीयुत कुलवाल विरुद्ध जयपूर महानगरपालिका या १९८६ च्या निकालात तर राज्यघटनेच्या कलम १९ अन्वर्ये बहाल करण्यात आलेले भाषण व अभिव्यक्तीचे स्वातंत्र्य आणि माहिती अधिकार यावाबतचे सुस्पष्ट संबंध सर्वोच्च न्यायालयाने विशद केले होते. शासनप्रणालीबाबत माहिती दिली नाही, तर नागरिक तरी आपले भाषण व अभिव्यक्तीचे स्वातंत्र्य कसे उपभोगू शकेल?

श्रीमती अरुणा रॉय यांची १९९० मधील राजस्थानातील 'मजदूर किसान शक्ती संघटन' चळवळ असो, अथवा बिलासपूरचे विभागीय आयुक्त श्रीयुत हर्ष मंडर यांनी सप्टेंबर १९९६ मध्ये 'अन्नधान्य वितरण व्यवस्था व रोजगार विनिमय' याबाबतची माहिती उघड करण्याचे दाखविलेले धारिष्ट्य असो, अथवा श्रीयुत अण्णा हजारे यांचे महाराष्ट्रातील माहितीच्या अधिकाराबाबतचे २००१ चे आंदोलन असो, अशा कितीतरी चळवळींचा परिपाक म्हणूनच केंद्र शासनाचा हा माहितीचा अधिकार कायदा १२ ऑक्टोबर २००५ पासून संपूर्ण भारतात लागू झाला आहे.

१७६६ मध्ये स्वीडनने सुरुवात केली आणि आतापर्यंत जगभग्रतल्या ५६ राष्ट्रांनी अशा प्रकारचे कायदे आपापल्या देशात लागू केलें आहेत आणि आपला देशही आता त्यांच्या पंक्तीत जाऊन बसला आहे. माहितीच्या अधिकाराबाबत अनेक पाऊलखुणा इतिहासात सापडतात. आपल्या देशाच्या गौरवशाली इतिहासात अनेक लोककल्याणकारी राजे-महाराजे होऊन गेले. त्यांच्या कारभारात, दृष्टिकोनात आणि त्यांच्या वागणुकीत जनतेचा माहितीचा अधिकार मान्य करण्याची आणि तक्रारी अथवा गाऱ्हाणी तात्काळ दूर करण्याची बीजे आढळतात. मुळातच सहिष्णू असलेली भारतीय मानसिकता लोकशाहीच्या यशस्वितेच्या मार्गाने अधिकाधिक
